# Golf Cart Safety

For the safety and security of everyone on the Town's roads, the Town has an ordinance regulating the operation and permitting of golf carts and other undersized motor vehicles while on any publicly-owned or -dedicated road, street, drive or other right-of-way within the corporate boundaries of the Town of Fairview.

## Golf Cart Rules of the Road

- The vehicle must have a **permit** duly issued by the Town of Fairview
- The time when the cart is being operated must be **after sunrise and before sunset**
- When in motion on a public street, the driver and every passenger in the golf cart must be seated in a seat designed to hold passengers; no person may stand or ride in the lap of the driver and/or other passenger of a golf cart while it is moving on a public street
- Golf cart or undersized motor vehicle **use in a public park, trail or on a public sidewalk is strictly prohibited.**
- Any person operating a golf cart must use proper hand signaling to illustrate intent of direction being traveled or the golf cart must be equipped with turn signal lamps
- The cart must be driven by a person with a **valid driver's license**
- The driver must maintain current financial responsibility (**insurance**) for the golf cart, as required of other passenger vehicles in the Texas Transportation Code
- The **maximum posted speed limit** on the public street must be **30 miles per hour** (MPH) or less; a golf cart may cross a public street that has a posted speed limit of more than 30 mph, if otherwise legally crossing at an intersection
- The cart must comply with all applicable federal, state and local laws and ordinances governing the operation of a vehicle
- Animals must be reasonably secured (i.e. safety harness, crate, passenger lap)

This means that golf carts must be driven by a licensed driver over the age of 16 or a permitted driver with a licensed passenger in the front seat. Additionally, any driver with a minor's provisional license may not drive with more than one person under the age of 21 that is not an immediate family member. Finally, in the State of Texas, there is also a Zero Tolerance Law for a driver under the age of 21 to have any detectable amount of alcohol in their system, which could lead to a driving while intoxicated (DWI) charge for the minor driver.

Beginning September 1, 2017, it became illegal in the State of Texas for all drivers, not just minors, to read, write or send any form of electronic messages while operating a motor vehicle, unless the vehicle is stopped.



By ordinance, anyone who violates the Town's ordinance or is unpermitted could be fined up to \$500 for each occurrence. If you see minors operating a golf cart or other rules being violated, please report the offending residence or driver to the Fairview Police Department non-emergency number, 972-886-4211, so an officer can inform the operators or parents of the ordinance rules so they can avoid future penalties.

## Permitting

The cost to obtain a valid Town-issued golf cart permit is \$60; permits are valid for two years, and have a biennial renewal fee of \$60 to maintain it. To obtain a permit, the golf cart is required to have headlamps, tail lamps, reflectors, mirrors, a parking brake, horn and a slow moving vehicle emblem in good working condition on it. Golf carts purchased after the effective date of the ordinance are also required to have brake lights.

Signed permit applications must be accompanied by a copy of a driver's license and proof of financial responsibility consistent with the minimum requirements of the Texas Transportation Code. Upon issuance, the permit stickers shall be attached and displayed upon the right front panel (driver's side) of the golf cart and upon the left rear panel as to be clearly visible.

## *Christmas Tree Fire Safety*

Christmas is around the corner and you don't want a simple mistake to set your Christmas tree and home ablaze. Here are a few fire safety tips for both live and artificial Christmas trees from your Fairview Fire Rescue:

- Always make sure Christmas lights are in safe, working condition. Keep an eye out for exposed or worn-out wires.
- Do not connect more than three strands of lights together.
- Keep your tree at least three feet away from exposed flames and heat sources.
- Check manufacturers' labels for suggested lights and decorations that are flame retardant.
- Always turn off the lights on your tree when it is not supervised.
- Watch children and pets to avoid the chewing of wires and prevent the tree from toppling over.
- Make sure artificial trees are flame retardant.
- Choose a live tree that looks fresh with green needles that do not fall off.
- Make sure your live tree stays hydrated and keep plenty of water in the base at all times.
- If a live tree develops brown and/or dropping needles, it is drying out and needs to be replaced.

## 2018 Trash Schedule Changes





Due to the increasing volume of trash and recycling being picked up within the Town, Republic Services will be adding a third pick up day to the Town's trash and recycling schedule in 2018.

Residents will continue to receive weekly trash and recycling services and one-time monthly brush/bulk collection services, limited to 12 cubic yards. However, beginning in 2018, the western portion of Town, including the Commercial Planned Development District (CPDD) pickup will occur on Mondays. Heritage Ranch pickups will continue to be on Tuesdays. And, the remainder of the eastern portion of Town will be picked up on Wednesdays.

# Town Quarterly Financial Report

## For Quarter Ending September 30, 2017



Monthly financial reports are prepared for the General Fund, Water and Sewer Fund, Solid Waste Fund, Debt Service Fund, Stormwater Fund and Fairview EDC/CDC Funds, these reports are presented to the Town Council at their monthly meetings. These monthly financials can be accessed on [fairviewtexas.org](http://fairviewtexas.org) by selecting Departments/Administration/Audit-Budget.

This report covers through September 30, 2017, which is the end of the fourth quarter of fiscal year 2016-17; therefore, it is generally desirable for year-to-date revenue totals to have achieved 100 percent of the budgeted amount and expenditures should generally not exceed 100 percent of the budgeted amounts. As the fiscal year just ended on September 30, there will be differences in the revenue and expenditure comparison between the current fiscal year and the prior fiscal year as the prior fiscal year includes year-end accruals for audit purposes, while the current fiscal year-end accrual entries have not yet been recorded; therefore, the financial report is expressly marked as “unaudited.”

### General Fund Analysis

Revenue collections in the General Fund for the twelfth month of fiscal year 2017 total \$7,995,152 and represent 96.2 percent of the total annual budget. Actual total collection for this fiscal year is \$75,740 lower than the prior fiscal year. Property tax increased by \$244,922 due to higher property valuations. Miscellaneous revenues increased \$219,463 from prior fiscal year primarily due to the Town receiving \$74,490 in proceeds from the sale of surplus assets as well as the Town receiving a portion of the proceeds of a short-term note payable used for capital purchases in the amount of \$115,437. Transfers from other funds decreased by \$435,000 due to one-time capital purchases in the prior year. Other revenue categories that are lower than the prior year are due to fiscal-year end accruals that have not been recorded for September 30, 2017, but had been recorded for the prior fiscal year.

General Fund expenditures total \$8,365,703 and represent 93.7 percent of the total annual budget. Expenditures are \$1,153,906 more than the previous year. The Police Department had an increase in salary & benefits of \$122,777 and dispatch services of \$14,939 from the prior fiscal year. Additionally, there was an increase of \$336,713 due to capital purchases. The Fire Department had an increase in salary & benefits of \$390,785 and an increase in capital related items of \$95,576 from prior year. The Public Works Department had an increase of \$237,905 from the prior fiscal year due to the “chip-seal” road maintenance project that occurred in October and November 2016. Additionally, there was an increase of \$110,102 due to capital purchases. Non-departmental expenditures were \$112,286 less than previous year due to timing of the 380-Agreement Sales Tax rebate payments. Other expenditure categories that are lower than prior year is due to fiscal year-end accruals that have not been recorded for September 30, 2017, but had been recorded for the prior fiscal year.

### Water and Sewer Fund Analysis

The Water and Sewer Fund revenues total \$5,093,677 and represent 92.1 percent of the total annual budget. This amount is \$262,031 lower than last year. Water sales were higher by \$217,390 and sewer sales were higher by \$89,592 than the previous year due to the Town increasing water and sewer rates by 15 percent. Miscellaneous revenue was \$95,282 less than previous year due to a smaller refund from North Texas Municipal Water District (NTMWD) on over-payment for billed water. The transfer from Debt Service Fund is \$445,758 less than the previous year due to decreased subsidizing of water/sewer debt by property taxes.

Expenses for the Water and Sewer Fund total \$5,665,738 and represent 85.1 percent of the annual budget. This amount is \$281,640 more than prior year. Water Department expenses

increased \$158,148 over the prior year due to increased cost of purchasing water from the NTMWD as well as the salary and benefits cost associated with an added employee. Other expense categories that are lower than prior year are due to fiscal-year end accruals that have not yet been recorded for September 30, 2017, but had been recorded for the prior fiscal year.

### Other Funds Analysis

The Debt Service Fund revenue and expenditures were \$1,360,114 and \$1,630,730 respectively less than the prior fiscal year due to the Town refunding a prior bond issuance. The Storm Water Fund expenses decreased \$182,347 from the prior fiscal year primarily due to the drainage study that was conducted last fiscal year. The revenues and expenditures for all the other operating funds are within an acceptable percentage range.

### Sales Tax Analysis

Sales tax revenue collections for the entire Town of Fairview (Town, Fairview EDC and Fairview CDC portions) for the twelfth month of fiscal year 2017 total \$3,138,188. Actual total collection this year is \$70,716 or 2.2 percent lower than last year.

The Town of Fairview received \$232,101 in sales tax revenue during the month of September 2017. This amount represents a decrease of \$152 or 0.1 percent less than September 2016.

Due to the timing, the sales tax received in the month of October 2017 can be reported in this financial report. The Town of Fairview received \$278,523 during the month of October 2017. This amount represents an increase of \$48,478 or 21.1 percent more than October 2016.
