BUILDING PERMIT FEES

Residential building permit fees

Residential building permit fees based on square footage:

(1) New residential dwellings and attached structures (including apartments, duplexes and condos).

(A) Base fee. Not more than 3-stories in height with a separate means of egress.

1,000 or less	\$650.00
1,001 to 1,250	\$825.00
1,251 to 1,500	\$975.00
1,501 to 1,750	\$1,150.00
1,751 to 2,000	\$1,300.00
2,001 to 2,250	\$1,500.00
2,251 to 2,500	\$1,700.00
2,501 to 3,000	\$1,950.00
3,001 to 3,500	\$2,300.00
3,501 to 4,000	\$2,600.00
4,001 to 4,500	\$2,925.00
4,501 or more	\$2,950.00 (+ \$0.65per/sq. ft. in excess of 4,500)

(B) Re-inspection fee for red tag.

(C) \$50.00 for the second re inspection and increasing in \$25.00 increments for each re-inspection of the same items thereafter (i.e..\$50.00,\$75.00,\$100.00

(D) All red tags must be paid before a certificate of occupancy is issued

(E) Plan review fees.

Remodel and detached accessory building plans (barns, stables, garages, cabanas, storage, ,pools, spas)
\$75.00

Residential Plan review \$300.00

Attached structures plan review fee (including apartments, duplexes, townhomes and condos) shall be 10% of the cost of the building permit fee

(F) Third-Party inspection/ plan review / consultants

Use of Outside Consultants for Independent Plan Review and/or Inspections Actual Cost if individual fees collected under this Section are exceeded. If an outside consultant is used entirely for the permit there is an additional 1% administration fee on the actual total cost.

Note: The plan review fee must be paid before they are reviewed, and permits are issued and is nonrefundable.

(2) Remodeling, additions, alterations, repairs, and fire damage permit fee.

(3) Detached accessory buildings (barns, stables, garages, cabanas, storage).

0–250 sq. ft.

\$100.00

Over 250 sq. ft.

\$100.00 + \$0.25 per sq. ft. over 250 sq. ft.

Septic

(i) Residential plan review: \$75.00.

(ii) Nonresidential review: \$100.00.

(iii) Single-family: \$335.00.

(iv) Non-single family: \$475.00.

(v) \$50.00 for the second re-inspection and increasing in \$25.00 increments for each re-inspection of the same items thereafter (i.e.\$50.00, \$75.00, \$100.00...).

All red tags must be paid before a certificate of occupancy is issued.

(b) Commercial plan review: 10% of the cost of the building permit fee.

Use of Outside Consultants for Independent Plan Review and/or Inspections Actual Cost if individual fees collected under this Section are exceeded. If an outside consultant is used entirely for the permit there is an additional 1% administration fee on the actual total cost.
